1053. <u>REPORTS FOR INFORMATION ONLY</u> Report from Churchtown Flood Action Group

Cllr. Mrs. S. Hogg reported the group were preparing a film about the construction of the bund and are holding an open afternoon to show the remarkable work done to protect Churchtown from flooding. The Duke of Westminster has been invited. The funding bid to the Big Lottery for two pumps has failed, but investigations are ongoing to provide a portable flood defence for the Memorial Hall at a cost of £30,000. The fence on the embankment behind the church was raised and the Parish Council will ask for it to be removed now.

1054. INFORMATION FOR COUNCILLORS

Flood Risk Management Works

Residents received informative letters about work installing additional gully grates and a repair on the Avenue. Traffic lights will be in operation from 1st October to 30th November.

The Mosaic

A tree was felled next to the Mosaic which devastated the Laurel shrubs around the area, the Parish Lengthsman has cutback and removed the damaged stems and the Clerk has replaced two Laurels.

Commissioned Seat
