Defibrillator for Churchtown Village

A consequence of the rise in mobiles phones BT began removing their public telephones and selling off the iconic red telephone boxes. Kirkland Parish Council purchased the one in the village and has recently upcycled it to house a defibrillator, which is now up and running. The telephone box, being listed, was refurbished with care and advice to and the help of villagers, Roger Barnes, Ray Truswell, Pam and Neil Buck, and Alastair Campbell. The Rotary kindly donated the funds to buy the defibrillator itself.

If you see someone has had a cardiac arrest, it's vital to call 999 and start CPR. The ambulance service will talk you through the process and tell you of the nearest defibrillator and how to access it.

These defibrillators are often known as public access defibrillators (PAD) as anyone can use them in an emergency. You shouldn't be afraid of using a defibrillator if someone has had a cardiac arrest.

This is my first newsletter as the new Chairman of Kirkland Parish Council. The Parish Council is keen that the precept it raises every year from the residents of the parish is used for the benefit of the local community. The annual accounts show that we have a healthy balance going forward and the Council would like to help support any local projects that people feel would be of benefit to the local community. Beware of invasive plant species! Japanese Knot weed has been found in the village and the Council informed Lancashire County Council who has now visited the site which is on public land. However, if you find it in your own garden, then you need to see to its removal yourself. In addition, Himalayan Balsam is an increasing problem and not just on river banks. Members of Kirkland WI recently spent a morning with Wyre Borough rangers tackling some of it on the river bank near the footbridge.

The Environment Agency has begun work on addressing the low spots on the river embankment between Kirkland Bridge on the A6 and the sewage works. Thanks go to Churchtown Flood Action group for their hard work in helping to bring this about.

Dog fouling is still a problem in the village, most dog owners are very responsible but it only takes one or two to spoil it for everyone else. Please pick up after your dog. It makes the village safer and a much nicer place for everyone else.

It is lovely to see the tubs around the village filled with summer plants and many thanks go to Mr and Mrs Myerscough for doing this on behalf of the Parish Council. Finally, a reminder that the shop and café are open in the Sunday School and the Council wish the venture well.

Churchtown Flood Group

The flood group and representative on the Parish Council are still campaigning vigorously on behalf of the village and have been assured that work will start in September. It is intended to increase the height of the bund at the back of the Sewerage works and work on any depressions in the bunds.

The group is working on obtaining more sensitive telemetry so that Churchtown does not receive erroneous Flood warnings. There was one in June that turned out to be a false alarm but it makes those of us who have been flooded, unnecessarily anxious knowing what can happen.
