## 1217. APOLOGIES

No apologies were received for this meeting.

## 1218. VACANCIES IN THE OFFICE OF PARISH COUNCILLOR

The Chairman welcomed our new Councillor, Mrs. Ivy Cutler; who lives in the village.

#### 1219. DECLARATION OF INTERESTS

Councillors were asked to disclosure any interests on matters to be considered at this meeting and reminded to update changes in their interests within 28 days.

Cllr. Mrs. K. Davies declared an interest to receiving payment on behalf of Churchtown in Bloom expenses.

## 1220. MINUTES OF THE PREVIOUS MEETING

Resolved: The minutes of the meeting held on 14th September, 2020, being previously circulated, was agreed and signed by the Chairman.

#### 1221. PUBLIC PARTICIPATION

Standing Orders were suspended.

The clerk had received no public requests to join the meeting

## **Lancashire County Councillor S. Turner**

Cllr. Turner was asked about Kirkland and Catterall St. Helen's Church of England Primary School parking, as it is again causing traffic problems on The Green and beyond. Cllr. Turner attended a site meeting with Councillors at the beginning of the year and has just heard County highways are to investigate the area this month. The Chairman also raised the deterioration of the A586 and the impact on houses in the village, roundels at the junction with the A6 and the proliferation of signs along the Avenue; which prevents the use of a speed indication device. The Parish Council will approach the Police to arrange for removal of the 'Panda' signs which are now so badly faded they cannot be read.

Standing Orders were resumed.

#### 1222. GARSTANG CHRISTMAS LIGHTS

Garstang Christmas Lights Committee is appealing for financial support towards the festive lights display in the town centre. Councillors considered the request in light of the present Covid pandemic curtailing fundraising efforts.

Resolved: Kirkland Parish Council to donate £50 towards Garstang Christmas lights.

#### 1223. CHURCHTOWN IN BLOOM

From the last meeting when Cllr. Mrs. K. Davies asked the Parish Council to consider donating £100 towards the Winter planting in the village? It was noted this planting will be in the Parish Council assets i.e. barrels in the village.

Resolved: Kirkland Parish Council to donate £100 towards the work of Churchtown in Bloom.

## 1224. ROYAL BRITISH LEGION DONATION

Councillors considered a donation to the work of the British Legion. With the present restrictions Remembrance services were nationally suspended.

Resolved: Kirkland Parish Council to donate £50 to the Royal British Legion.

#### 1225. NORTHWEST AMBULANCE SERVICE - SAVE A LIFE

Cllr. Mrs. M. McLeod raised the online fundraising project from the North West Ambulance Service. Background information was circulated. Kirkland and Catterall St. Helen's Church of England Primary School and the Parish Council need to work together on this subject, but this is not possible at present.

Resolved: Kirkland Parish Council to defer as it is not possible under the present circumstances, but to re-visit next year.

## 1228. VERBAL REPORTS FOR INFORMATION

#### Kirkland Memorial Hall

Cllr. Mrs. M. McLeod reported the October AGM was postponed, but the accounts were audited. Before the latest lockdown; classes had resumed in the hall.

#### **School House Trust**

Cllr. Mrs. K. Davies reported on a virtual AGM on 2nd November. Investments of £234,000 made a loss; due to Covid. Kirkland and Catterall St. Helen's Church of England Primary School has requested a grant of £480; for additional lessons needed for a vulnerable pupil.

#### Churchtown in Bloom

Cllr. Mrs. K. Davies reported on two online meetings where new ways of working were explored. The Winter bedding is planted and displays were organised for Halloween and Remembrance Sunday. The Woodland Trust is to send bare-rooted trees, to be planted immediately on receipt.

# Parish Lengthsman

The Councillors are pleased with the work undertaken and he is open to accept other locations within the parish; until the leaves have all dropped the gullies will need clearing continually. The Christmas Tree barriers are to be moved into the Hearse House. It was suggested to spray the barriers green to be more sympathetic with the tree and perhaps use a picket fence in front on the Horns Inn site.

## **Proposed Telecom Poles in Village**

Information circulated from a resident contacted by Open Reach and the Parish Council has replied directly to Open Reach asking the Parish Council is kept informed of plans for the poles. Councillors attending a site meeting on Monday 9th November were told the wires are to go underground with no visible poles in the village's conservation area.
